These prices are effective January 1, 2020, but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain in writing on the statement we provide describing the funeral goods and services you selected. This list does not included prices for certain items that you may ask us to buy for you, such as cemetery, or crematory services, flowers and newspaper notices, The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected. We do not charge you for our services in buying these items.

**SERVICES**

- 1. **Basic Services of the Funeral Director and Staff.....\$ 2,100.00**  
 \*Note: This non-declinable fee for basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in the charge of a direct cremation, immediate burial, and the charge of forwarding or receiving of remains). Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to the initial request for service; the arrangements conference with the family and responsible parties; arrangement of funerals; preparation and filing of necessary authorizations and permits; recording of vital statistics; preparation and placement of obituary notices; shelter of the remains; and coordination with those providing other portions of the funeral, e.g. cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to or facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory cost, record keeping, and secretarial and administrative expenses.
  
- 2. **Embalming.....\$ 525.00**  
 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. This service provides professional care and preparation of the deceased. Brady & Levesque Funeral Home's highly trained and exceptionally qualified staff are made available twenty four hours a day to cleanse, sanitize, embalm and prepare for viewing and/or other disposition of the body using modern, scientific methods to safely ensure public health, proper discharge of infectious materials, and contaminants. All procedures are in strict compliance with OSHA guidelines.
  
- 3. **Other Care and Preparation of the Body**

If for any reason, the cremated remains are held at our funeral home for any length of time with no arrangement for return to family or interment, this charge will be applied every month or portion thereof, commencing on the 7<sup>th</sup> day after cremation, unless prior arrangements have been made.

### 12. Receiving from Another Funeral Home.....\$ 2,475.00

This charge includes: The Basic Services of the Funeral Director and Staff, transfer of the decedent from a local common carrier to our funeral home, and a service vehicle for transportation to the burial location.

## IMMEDIATE BURIAL OPTIONS

**13. Immediate burial without a visitation or ceremonies available from.....\$ 3,560.00 to \$ 3,105.00**

The charge of any immediate burial options includes the Basic Services of Funeral Director and Staff, transfer of the decedent from the place of death to our funeral home, sanitary care of the deceased, and a service vehicle for transportation to the burial location, All direct burials are scheduled according to the cemetery availability and are unwitnessed by the family. This charge does not include any cemetery fees, merchandise or ceremonies or services at our funeral home, or another facility.

A. Immediate Burial with a container provided by the purchaser.....\$ 3,105.00

## DIRECT CREMATION OPTIONS

**14. Direct Cremation without a visitation or ceremonies available from.....\$ 3,125.00 to \$ 1,885.00**

Our charge for Direct Cremation (without ceremonies) includes: the Basic Services of Funeral Director and Staff, transfer of the decedent from the place of death to our funeral home, transportation to and from the crematory and the cremation fee.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide range from fiberboard (heavy cardboard) to hardwood (pine and poplar). A complete list will be provided at the funeral home.

**15. Body Donation to a Medical School Facility.....\$ 3,105.00**

This charge includes the basic service of funeral director and staff, transfer of the remains from the place of death to our funeral home, and transfer of the remains to the appropriate medical school, (within a radius of 30 miles) and preparation and filing of necessary permits and certificates.

**16.** Funds may be available for final disposition through the Vermont Department of PATH, General Assistance Burial Program, for those who qualify.
